Thank you to everyone who returned a Payment Preference Form following our December 2025 mailing. We appreciate your cooperation as we move forward with offering additional payment options this spring.

Payment Amounts — Effective May 1, 2026

As previewed in our December letter, updated payment amounts take effect beginning with May dues. Current dues of \$96.45 remain in place through April.

- **Clubhouse Dues: \$97.00 per month (effective May 1)**

Monthly fees are due on the 1st of each month. Payments not received by the 15th will be considered late and subject to a 10% late fee.

Online Payment Options — Now Available

Beginning in May, all residents with an email address on file will receive their monthly invoice by email which will provide an option for payment to be made online by ACH bank draft or credit/debit card.

Invoice emails will be sent from calahillsbilling@gmail.com. Please add this address to your contacts to ensure delivery.

If you currently pay by check or bank bill pay, no action is required. Simply continue paying as you always have. The payment link is optional and provided as a convenience only.

If you do not receive your May dues notice by email, please contact us so we can update your records.

Bank Bill Pay Users — Action Required

If you currently pay through your bank's bill pay service, please log in and update your payment amount to **\$97.00 effective May 1**. Payments received at the prior amount after that date may result in an open balance on your account. Members who continue to pay old amounts may be subject to late fees on the unpaid balances.
